Revised CEA Career Ladder Timeline

December 15 – In-Depth and Outreach Program Summaries Due – Can be edited until April 1 – Cannot be uploaded into TexasData after February 15

January – March – Discussion with Supervisor (District Extension Administrator or County Extension Director) About Intent to Apply

May 1 – Intent to Apply Form Due to District Extension Administrator

June 1 – Preliminary Version of Promotion Packet Sent to Level IV Mentors for Review

July 15 – Final Version of Promotion Packet Due to District Extension Administrator

July 15 – August 31 – Regional Leadership Team and Regional Peer Review Committee Meet to Review Promotion Packets

September 1- 15 – Promotion Packets Seeking Promotion to Level IV Returned to CEAs for MINOR edits

September 15 – Promotion Packets Due to Senior Administration Team with both Peer Review and Regional Leadership Team Votes and Comments

October - State Peer Review Committee Reviews All Promotion Packets Seeking Promotion to Level IV

December 1 – CEAs Seeking Promotion to Level II, III, and IV Are Notified of Promotion Decision

September 1 – Promotion Decisions Become Effective
